Dear Kevin:

Your request to expand the Manosh building located at 85 Industrial Park Road, in Hardwick, Vermont is approved in accord with the following understandings and conditions: As described, the project is a 2,160 square foot expansion to add warehouse space to the exiting building. This expansion will not result in additional water use or sewage discharges from the facility. As part of the expansion Manosh Properties will not excavate into the aquifer or in any way impact the operation of the Town water wells located in the industrial park. Please note the expansion you are planning is located in the Town's public drinking water Source Protection Area, see the enclosed map information. This is an area where activities that are conducted can't lead to a potential contamination of the water supply.

Your request for approval of this construction within the Source Protection Area will be conditioned on Manosh Properties following industry specific best management practices to ensure no negative impacts to the drinking water supply. You will be required to provide the Town an annual inventory of all hazardous materials stored and/or used in the building and or nearby the facility. The inventory must be provided to the Town Manager's Office by the first of July of each year.

We will be updating the source protection plan ongoing with information that relates to operations within your building ongoing. If you have questions or comments on anything noted here, please feel free to contact me.






Town of Hardwick Public Water Supply Source Protection Area – WSID # 5039. Source ANR website @ $\,$
