7. Presentation:

***Sacha Pealer,** Northeastern River Scientist and Floodplain Manager and **Staci Pomeroy**, River Scientist for the Lamoille River (VT Agency of Natural Resources personnel) were guests. They presented information about trouble spots along the Lamoille River in Hardwick. and how the Conservation Commission could get involved in riparian mitigation.

*Staci showed maps of **2 projects** that are (tentatively) scheduled for this summer, involving the Lamoille River. One project involves stabilizing erosion near the junction of Rtes#15 and 16. The other project is located just west along the Lamoille.

*Staci suggested **that if the CC chose a project, our role** could include outreach to the public to build awareness and support, contact with landowners, and volunteers for planting. Staci also said she could partner with us.

*Staci mentioned the **Trees for Streams** program . The contact for information is Kerri O'Brien, Manager, Caledonia County Conservation District.

8. After presentation comments

*Rachel said she wanted to talk with Bruce Kaufman about the riverbanks that are part of his land.

*Ben recommended looking at the Orleans County

Conservation District current newsletter and plant sale list for possible plant sources for next year.
