#### Manager's Report

- Tentatively reserved 2,000 WT (500 DT @ 25% solids of processed sludge) for disposal at the Englobe facility in St. Henri Quebec. The 500 DT amount is a quarter of what P & H Senesac estimations came out to and a little more than half of VT Rural Water's estimations. Englobe needed a commitment from The Town to plan for their 2022 allotment of material they accept. This amount can be changed but they needed something to reserve space. The processing of 500 DT comes out to \$476,830.00 with a disposal fee of \$105,700.00 this does not include trucking which will have to go out for bid when we decide on how much we are going to process.
- I was contacted with a request to bring back the Restorative Justice Program back. We currently have \$9,500 unrestricted program funds still available that we have had for two years. The current Restorative Justice program available to Hardwick is out of the Restorative Justice Center in St. Johnsbury. In the past, they have reached out for community involvement with in Hardwick and people have not stepped forward to get involved. I will continue to speak with these interested folks and come up with a plan to move forward with the board's approval.
- I submitted a request to the Vermont Criminal Justice Training Council (VCJTC) for a waiver for Scott Gagnon. Scott has worked for the VT Medical Examiners office as an Assistant Medical Examiner. The wavier request is for a Death investigation Certification. This would eliminate the need for the State Police or another police agency to respond to Hardwick for a death investigation.
- Meeting with the Emily Finnigan from the Caledonia County Natural Resource Conservation District (NRCD) and the engineers involved in the Stormwater Project in the parking lot at 64 North Main Street (lower level of the Jeudevine Manson). This project involves several easements for construction and maintenance of the system. The town will be responsible for the routine maintenance after completion. I will be attending a second meeting in February with NRCD the land owner and engineers to discuss construction which will have an effect on parking in the area and a mild effect on traffic. This project will be going out to bid in the late winter and will be coordinated by NRDC and run by SLR environmental consulting's Waterbury, VT office.

Assessor appointment for elected lister duties

The Listers for the Town of Hardwick have retired effective 12/31/2021. The Hardwick Town Charter currently defines the position of Lister as elected. Although there are proposed Town Charter changes to the State of Vermont, they have not yet been finalized. A temporary appointment will need to be made to statutorily fill the position (17 V.S.A. § 2651c).

The Selectboard has the ability to appoint an Assessor. The Assessor (NEMC) would then be granted the same powers, and able to perform the same duties as an elected Lister under the provisions of Title 32. Duties such as homestead certification or finalizing a grand list require a signature from the appropriate municipal agent. These duties could not be statutorily performed without the appointment to the Assessor.

If you decide to appoint NEMC with these same duties and responsibilities of a Lister, it would be valid until the next annual town meeting. Depending on the status of the proposed charter changes, this issue may need to be revisited after that.

I appreciate your consideration into this matter and look forward to your decision.

Title 17: Elections

**Chapter 055: Local Elections** 

Subchapter 002 : Town Meetings And Local Elections In General

(Cite as: 17 V.S.A. § 2651c)

### § 2651c. Lack of elected lister; appointment of lister; elimination of office

(a)(1) Notwithstanding any other provisions of law to the contrary and except as provided in subsection (b) of this section, in the event the board of listers of a town falls below a majority and the selectboard is unable to find a person or persons to appoint as a lister or listers under the provisions of 24 V.S.A. § 963, the selectboard may appoint an assessor to perform the duties of a lister as set forth in Title 32 until the next annual meeting.

- (2) The appointed person need not be a resident of the town and shall have the same powers and be subject to the same duties and penalties as a duly elected lister for the town.
  - (b)(1) A town may vote by ballot at an annual meeting to eliminate the office of lister.
- (2)(A) If a town votes to eliminate the office of lister, the selectboard shall contract with or employ a professionally qualified assessor, who need not be a resident of the town.
- (B) The assessor shall have the same powers, discharge the same duties, proceed in the discharge thereof in the same manner, and be subject to the same liabilities as are prescribed for listers or the board of listers under the provisions of Title 32.
- (3) A vote to eliminate the office of lister shall remain in effect until rescinded by majority vote of the registered voters present and voting at an annual meeting warned for that purpose.
- (c) The term of office of any lister in office on the date a town votes to eliminate that office shall expire on the 45th day after the vote or on the date upon which the selectboard appoints an assessor under this subsection, whichever occurs first.
- (d) The authority to vote to eliminate the office of lister as provided in this section shall extend to all towns except those towns that have a charter that specifically provides for the election or appointment of the office of lister.
