6:00 P.M. – Eric Remick, Select Board Chair, called the meeting to order.

6:01 P.M. – Set/Adjust Agenda- Item #6 Select Board to review the SE Group Proposal and authorize the Town Manager to acknowledge and accept Pedestrian Bridge and Park Phase 2.

Upon motion by Danny Hale, seconded by Elizabeth Dow, the Select Board voted unanimously to approve the adjusted agenda as stated.

6:02 P.M. – Communication from the audience – Ken Wetherell stated that a section of the Rail Trail behind the Yellow Barn on Route 15 is shut down. Ken presented to the Select Board an application to allow users to temporarily use Route 15 from Wright Farm Road to the Rail Trail intersection just past Log Yard Drive.

Upon motion by Elizabeth Dow, seconded by Shari Cornish, the Select Board voted 4-0 to authorize Eric Remick to sign the application. Danny Hale abstained from voting.

6:08 P.M. – Select Board to approve the minutes of the Regular Select Board meeting of May 4, 2023

Upon motion by Ceilidh Galloway-Kane, seconded by Elizabeth Dow, the Select Board voted unanimously to approve the minutes of the Regular Select Board meeting of May 4, 2023.

6:08 P.M. – 6:14 P.M. Town Manager Report- Given by Eric Remick

Eric reported the Vermont Drinking Water Source Revolving Fund application was submitted, electrical service for the Library is in process, the sidewalks on West Church and North Main Streets will be closed during the Library construction this summer. Please take caution and avoid that area. He also reported that Truline Land Survey reached out to survey the Town's property on Carey Road. The Select Board unanimously agreed to have the Town Manager move forward with this survey. Next, the Community Development Coordinator and the Town Manager will be meeting with the SE Group on May 24. See the Town Manager's report for more information.

The Select Board requested that the Library attend a future meeting to talk about the expansion project. Tom reported that he met with Gravel Construction, and electrical personnel about the Library, and the project will

start after Memorial Day.

6:14 P.M. – 6:19 P.M. Road Foreman Report – Given by Tom Fadden

Tom reported that they have been grading, line painting, hauling winter sand, hanging up the banners and American Flags throughout downtown, and taking care of a few water and sewer issues that have occurred. He also reported that street sweeping and brush cutting will begin Monday, May 22. The new excavator will also arrive on Monday May 22, and he reported that the new F550 is in the process of being built.

Eric asked about the sidewalks near Brickhouse Road in East Hardwick. Tom mentioned that the Town Manager is working on this currently.

Lastly, Tom mentioned that Hardwick Fire Department responded to a house fire on Brush Street recently. He wanted to thank Chief Henry and the Hardwick Police Officers that helped that night. Chief Henry was able to have an officer stay throughout the night with Tom to secure the building, and Tom really appreciated the help. Mike responded that he also wanted to thank Tom and the fire personnel that assisted that night. Mike stated that the fire departments did a phenomenal job, and they were able to put the fire out quickly. The teamwork was great that night!

6:19 P.M. – 6:28 P.M. Hardwick Police Department Report - Given by Police Chief Mike Henry

Officer Joseph Rossi spoke first. He has been with the Hardwick Police Department for about three years. Officer Rossi often visited the schools while on duty and had lunch with the students. He made a huge impact on the students, and the students made an impact on him as well. He stated that Hardwick is a nice little Town, and it has been a pleasure to work for this community. Unfortunately, due to some injuries he received while serving our country, he must retire and leave the department. He took a moment to thank Chief Henry and stated that he had done a magnificent job. The Select Board thanked Officer Rossi for his time and dedication. Officer Rossi will be missed, and we all wish him nothing but the best in his future. Chief Henry also thanked Officer Rossi for his service and dedication.

Chief Henry reported that Officer Barnard has been working on computer crimes and is currently working on an international investigation that has around three hundred victims.

The Hardwick Police Department has ordered their electric bike. They have been patrolling the Village and the Rail Trail.

6:28 P.M. – **6:42 P.M.** Hardwick Electric Department Report - Given by Roger Prevot

Roger Prevot reported that Hardwick Electric Department (HED) will be putting an EV charging station located at the HED's main building on North Main Street. This will be installed in the first week of June.

Roger also reported about Purchased Power and how the revenue is below budget due to the hard winter; however, they are now starting to save power again. Wolcott Hydro and the H11 project are starting to produce more power. The winter months reflect the budget differently than the spring and summer months, and this is something that HED is trying to work on and balance.

Next, they are outsourcing the installation of the Fiber.

HED had a Natural Resource inspection done, and the inspection went well.

Lastly, Roger stated that Hardwick Electric Commissioners meetings are public meetings, and anyone is welcome to come. There is an in-person and a zoom option. The meetings are also on their website.
