VHB Consultants will be presenting the final set of concepts to improve our existing issues in this area.






### We Want to Hear from You

Re: New Road Name

To the Hardwick Select Board Members,

When three or more property owners share a driveway, it is encouraged to turn that driveway into a road and have all owners agree on a road name.

It has recently come to my attention that there are three homeowners that live off Center Road that share the same driveway. I wrote each homeowner a letter on November 12, 2025, saying that I needed to turn their driveway into a private road name. I also stated that I would appreciate suggestions to bring to the board for the December 18 meeting. There was email exchange from two of the homeowners with suggestions.

Here are the suggestions that have already been approved by the state:

- ~ Clover Lane
- ~ Fox Run Lane
- ~ Fox Briar Way

If the board approves one of the three names, we can have a motion for Thursday night. If the board would like to go with another name, then I will have to get it approved with the state and then I would need official approval at the January 8, 2025, Select Board meeting.
